- **Overview**

The East Asian Law Department supports the Law School's long-standing research interest in the legal systems of East Asia, covering primarily China, Japan, and South Korea, but also including Taiwan and North Korea. We provide this support in several ways, by evaluating, selecting, cataloging, and providing training for the use of online and print resources. This work also supports the needs and interests of patrons outside the UW Law School community, including University of Washington non-law, Seattle, Washington state, regional, national, and even international constituencies seeking information about the legal systems of East Asia.

Primary UW Law School users include Professors Dongsheng Zang (Chinese), Jonathan Kang (Korean), Jane Winn (Chinese), Toshiko Takenaka (Japanese), Veronica Taylor (Japanese), Asian Law LLM and PhD students, and IP LLM students. We also serve Law School constituencies such as the Asian Law Center, CASRIP, and Pacific Rim Law and Policy Journal. Our service includes providing reference consultations, doing presentations on legal research in East Asia, setting up and maintaining access to databases and print continuing resources, selecting and acquiring print monographic publications, and creating and maintaining catalog records for all types of CJK-language resources.
