This table has been prepared to show you placement information for the past 9 years. In years prior to 2005, employment within three months of graduation was 100 percent.

2009 was the exception to this general rule when hiring freezes, layoffs, and economic uncertainty reduced the number of posted entry-level positions. That year, four out of eleven graduates found full-time employment while the other seven managed a variety of part-time positions. 2010 saw a recovery such that six graduates had full-time law librarian positions within three months of graduation, and the seventh graduate found a temporary position working as a law librarian.

Prospects for 2016 graduates look very promising with many posted entry-level positions all over the country (6 have already been hired). As has been the case in the past years, very few permanent full or part time law librarian positions are available in the Puget Sound region.
