Getting Started: Research Strategy

- Preliminary Analysis
 - Assess knowledge
 - Consult secondary sources for background on topic and citations to primary law
- Gather, read, and analyze primary law
- Update research and refine preliminary conclusions

Searching for Sources of International Law

Treaty Research:

- Multilateral treaty collection resources
 - University of Washington Gallagher Law Library Guide, "Treaties & Other International Agreements" (<http://lib.law.washington.edu/ref/treaties.html>)
 - United Nations Treaty Collection (<http://treaties.un.org/Pages/Home.aspx?lang=en>). Includes the *United Nations Treaty Series* (U.N.T.S.) database. U.N.T.S. also is available in print at Compact Stacks KZ172 .T74.
 - HeinOnline's "Treaties and Agreements Library" includes all U.S. treaties, whether currently in-force, expired, or not-yet officially published (http://www.heinonline.org/HOL/Index?collection=ustreaties&set_as_cursor=clear)
 - "FLARE Index to Treaties" is a searchable database of basic information on over 2,000 of the most significant multilateral treaties and some bilateral treaties concluded between 1353 – present. Includes citations and links where available (<http://193.62.18.232/dbtw-wpd/textbase/treatysearch.htm>)
 - University of Minnesota's "Frequently-Cited Treaties and Other International Instruments" (<http://library.law.umn.edu/researchguides/most-cited.html>) provides a succinct list of important treaties with citations; entries are linked to EISIL and HeinOnline when available.

- International Legal Materials (I.L.M.) publishes selected treaties and agreements. Current issues at Reference Area KZ64 .I58, on LexisNexis, HeinOnline, and Westlaw: ILM.
